ORDER

On February 17, 1982, a hearing was held concerning South Central Bell Telephone Company's ("Bell") Series 5000 Channel Service ("Telpak") tariff filing. In the course of the hearing, questions were raised that required unavailable information. The Commission continued the case and informed Bell that an Order requesting additional information would be forthcoming.

IT IS THEREFORE ORDERED that Bell shall file an original and five copies of the following information with the Commission on or before April 1, 1982:

(1) Orders of the Public Service Commissions of Alabama, Louisiana, Mississippi, and Tennessez concerning applications to grandfather and/or eliminate Telpak.

(2) A demand analysis and billing summary of all Telpak customer accounts, including both account records maintained by mechanical means and account records maintained by manual means. The demand analysis and billing summary shall be furnished as of March 1, 1982. Account records as of March 1, 1982, shall be reproduced and maintained in such a manner that they may be furnished to the Commission on request.



(3) The monthly bill for Telpak services rendered to the Commonwealth of Kentucky during the period January through December, 1981. An analysis of each monthly bill which shows a breakdown of channel mileage, channel termination, associated equipment, and other applicable charges, including other company billing.

(4) A copy of monthly billing reconciliation documents furnished the Commonwealth of Kentucky during the period January through December, 1981.

(5) A reconciliation of Ebbert Exhibit 3, Page 5, and Sims Exhibit 1, Page 1, as further detailed in Sims Exhibit 2, Pages 1-12. The reconciliation shall show a comparison of channel mileage, channel termination, associated equipment, and other applicable charges, including other company billing, and an explanation of any difference.

(6) A copy of work papers used in the preparation ofEbbert Exhibit 3, Page 5.

(7) A copy of cost studies or other documents used in the preparation of Ebbert Exhibit 2.

(8) A copy of the Restructured Private Line ("RPL") embedded cost study furnished the Commission in Case No. 7774, modified to reflect Telpak cost data. The modified study should be in sufficient detail to show each item of cost assigned Telpak services. The basis used to allocate each item of cost should be fully explained.

(9) The specific date of the one-day Telpak billing analysis used in the preparation of Ebbert Exhibits 1 and 3, Page 5.

- (10) The following data on Ebbert Exhibit 1:
 - a. The cost data in Format A.
 - b. The comparative private line revenue in Format B.

IT IS FURTHER ORDERED that Bell shall file one copy of the above information with each party of record by April 1, 1982, except that information determined to be proprietary and protected by order of the Commission in Case No. 5954.

IT IS FURTHER ORDERED that in the event the above information is not filed in a timely manner, the Commission may dismiss the case without prejudice, absent a Motion for Extension of Time for good cause.
