ORDER

IT IS ORDERED that East Kentucky Power Cooperatives, Inc., shall file an original and five copies of the following information with the Commission by February 19, 1982, with copies to all parties of record. Each item should be appropriately indexed and careful attention should be given to insure that all copied material is legible.

Information Request No. 2

1. Dates and all associated costs of the most recent turbine overhauls for each generating unit.
2. Actual right-of-way maintenance expenses for the test year and the twelve months immediately preceding the test year, in comparative form. Show number of acres sprayed or mowed and costs for each type of maintenance, and the number of hours and costs of danger cutting.
3. The number of poles treated during the test year in the current pole treatment program and the current cost to replace an individual pole.

4. a. The amount of non-labor operation and maintenance expense for each generating unit for the test year.
 - b. Net KWH generation for each generating unit for the test year and the 12 months immediately preceding the test year.
 - c. A schedule of the maintenance performed during the test year at Spurlock No. 2 that was covered by warranties.
5. For the test year show the date(s) of property valuations, the amount of the valuations, and the property tax expense in a format similar to Exhibit I, Schedule E of the application.
6. The Board Resolution approving the November 1981 salary and wage increase of 7.25%.
7. FFB interest rates for both 34 year and 2 year maturity loans for the first day of the month for each month of the test year and all available months subsequent to the test year.
8. A breakdown by accounts of the estimated cost of \$6,470,319 of the energy control center.
9. A comparison of the number of customers served by East Kentucky's member cooperatives at the end of each month of the test year.
10. A detailed summary of the magnitude and cost of the end-use survey of the consumers of the member cooperatives .
11. The cost incurred during the test year for the power rate study performed by Stanley Consultants in connection with Case No. 7981.
12. For the test year and the 12 months immediately preceding the test year a detailed analysis of expenditures for

Planning & Investigative Studies and Preliminary Work Pending
Availability of Intermediate Financing.

13. From Exhibit I, Schedule O, of the application: Show which of the non-revenue facilities will be replacing existing facilities, and show the cost of the facilities being replaced.
