## ORDER

On January 26, 1982, Oldham County Water District ("Oldham County") filed a revised tariff sheet with the Public Service Commission ("Commission"), in which it proposed to establish minimum bill rates for water service using meters larger than 5/8-inch meters, to establish a flat deposit amount, and to increase certain service charges to be effective March 1, 1982. On February 16, 1982, the Commission entered its Order suspending application of the proposed rates and charges for a period of 5 months beginning March 1, 1982. Subsequently, on March 19, 1982, the Commission issued an Order requesting additional information which was filed on April 1, 1982.

The Commission, having reviewed the evidence of record and being advised, is of the opinion and finds that:

- 1. Establishment of a flat rate deposit for all customers is contrary to 807 KAR 5:006, Section 7. Oldham County has failed to show good cause for deviation from the regulation. Therefore, the proposed flat rate deposit should be denied.
- 2. The increases in service charges proposed by Oldham County are fair, just and reasonable and should be approved.

- 3. The minimum bill rates proposed by Oldham County are unfair, unjust and unreasonable in that these rates applied to the proposed usage levels would constitute a rate increase for some 63 customers served by the larger meters and would produce approximately \$5,454 in additional annual revenue without sufficient notification or justification. The rates should, therefore, be denied.
- 4. The minimum bill rates in Appendix A are the fair, just and reasonable rates to be charged by Oldham County for large meter service in that the minimum usage levels have been adjusted to reflect the associated costs in accordance with Oldham County's approved rate schedule.

IT IS THEREFORE ORDERED that deviation from 807 KAR 5:006, Section 7, Deposits, be and it hereby is denied.

IT IS FURTHER ORDERED that the service charges proposed by Oldham County in Appendix A be and they hereby are approved for service rendered on and after the date of this Order.

IT IS FURTHER ORDERED that the minimum bill rates proposed by Oldham County be and they hereby are denied.

IT IS FURTHER ORDERED that the minimum bill rates in Appendix A be and they hereby are approved for service rendered on and after the date of this Order.

IT IS FURTHER ORDERED that within 30 days of the date of this Order, Oldham County shall file its revised tariff sheets setting out the rates and charges approved herein.
