INTERIM ORDER

On April 16, 1982, Campbell County Water District ("District") filed an application with the Commission for authority to acquire and operate the existing water distribution facilities of the City of Silver Grove ("Silver Grove"), to construct a connecting water supply main, to assume certain financial obligations and to reinforce the District's high and low pressure system.

A hearing was held on this matter on June 22, 1982, at the Commission's office in Frankfort, Kentucky.

Based upon the evidence of record, and being advised, the Commission hereby finds that:

1. The District was duly organized pursuant to KRS Chapter 74 and has the ability to acquire and operate an existing water system.

2. The District may acquire and operate an existing water system only if it lies wholly within the District's territorial limits as established by the county judge/executive.

3. The existing water distribution system of Silver Grove does not lie within the territorial limits of the District.

4. The District has failed to submit any evidence to support its request for authority to assume financial obligations.

5. The District has advised the Commission that reinforcements to its high and low pressure system may be needed in the future but there are no definite plans to construct any reinforcements.

IT IS THEREFORE ORDERED that the District's request for authority to acquire and operate the Silver Grove water distribution facilities and to construct a connecting water supply main be and it hereby is held in abeyance until the District has enlarged its territorial limits to include the Silver Grove facilities.

IT IS FURTHER ORDERED that the District's request for authority to assume financial obligations be and it hereby is denied.

IT IS FURTHER ORDERED that the District's request to reinforce its existing high and low pressure service systems be and it hereby is denied.
