## ORDER

On November 23, 1982, the Commission issued its Order in Case No. 8546 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates when the wholesale cost of gas is increased or decreased.

On November 15, 1982, Elzie Neeley Gas Company ("Elzie Neeley") notified the Commission that its wholesale cost of gas would be decreased by its supplier, Columbia Gas of Kentucky, Inc., ("Columbia"), and submitted with its notice certain information in compliance with its purchased gas adjustment clause on file with this Commission.

After reviewing the notice filed in this case and being advised, the Commission is of the opinion and finds that:

1. Elzie Neeley's notice of November 15, 1982, set out certain revisions in rates which Elzie Neeley proposed to place into effect, said rates being designed to pass on the wholesale decrease in price from its supplier in the amount of \$282 or \$0.02 per Mcf.

- 2. Due to the retroactive nature of Columbia's decrease, Elzie Neeley should report to the Commission any excess revenues collected during the period from October 31, 1982, to the date the proposed rates are implemented, along with a plan to refund any excess collections to its customers.
- 3. Elzie Neeley's adjustment in rates under the purchased gas adjustment clause approved by the Commission in its Order in Case No. 8546 dated November 23, 1982, is fair, just and reasonable, in the public interest and should be effective with gas supplied on and after October 31, 1982.

IT IS THEREFORE ORDERED that the rates in Appendix A be and they hereby are approved effective for gas supplied on and after October 31, 1982.

IT IS FURTHER ORDERED that Elzie Neeley shall report to the Commission any excess revenues collected during the period from October 31, 1982, to the date the proposed rates are implemented, along with a plan to refund any excess collections.

IT IS FURTHER ORDERED that within 30 days from the date the decreased cost of gas becomes effective, Elzie Neeley shall file with the Commission its revised tariff sheets setting out the rates approved herein.

The following rates are prescribed for the customers in the area served by Elzie Neeley Gas Company, Inc. All other rates and charges not specifically mentioned herein shall remain the same as those in effect prior to the date of this Order.

First 1 Mcf

\$8.20 Minimum Bill

Over 1 Mcf

7.21 per Mcf
