O R D E R

IT IS ORDERED that Union Light, Heat and Power Company ("ULH&P") shall file an original and six copies of the following information with the Commission by January 7, 1983. Each copy of the data requested should be placed in a bound volume with each item tabbed. When a number of sheets is required for an item, each sheet should be appropriately indexed; for example, Item 1(a), Sheet 2 of 6. ULH&P shall furnish with each response the name of the witness who will be available at the public hearing for responding to questions concerning each area of information requested. Careful attention should be given to copied material to insure that it is legible. If neither the requested information nor a motion for an extension of time is filed by the stated date, the fuel adjustment clause may be suspended.

1. Select a test month from the period under review to be used as the base period (b), and include a comprehensive

detailed explanation of the factors considered in the selection of this month as being representative of the net generating cost per MWH which ULH&P can reasonably expect to incur during the next 2-year period.

2. Provide a calculation of the fossil fuel costs F(b) that ULH&P proposes to use in calculating the base period fuel cost. The calculation should show each component of F as defined by 807 KAR 5:056, and ULH&P should provide a detailed explanation of the reasons it believes the fuel cost in the selected base period is representative of the level of fuel cost which ULH&P can expect to incur during the next 2-year period.

3. Provide a schedule showing each component of sales as defined by 807 KAR 5:056 in the selected base period (b), and give a detailed explanation of the reasons ULH&P believes the sales in the selected base period (b) are representative of the level of KWH sales which ULH&P can expect to derive from the level of fuel cost incurred during the selected base period (b).

4. Provide a list of firm power commitments for ULH&P from November 1, 1982 through October 31, 1984 (include the electric company's name, MW, and purpose; for example, peaking, emergency, etc.).

(a) Purchases

(b) Sales

5. Provide the following line loss information:

- (a) A schedule of the calculation of the 12-month average lines loss by month for the period of November 1980 through October 1982
- (b) A discussion of the steps that have been taken to reduce line loss during this period

6. Provide a copy of Cincinnati Gas and Electric's ("CG&E") most recent fuel clause filings with the Federal Energy Regulatory Commission pertaining to the determination of CG&E's fuel adjustment clause rate to ULH&P. Only two copies need be provided for this item.

7. Provide a schedule showing the calculation of ULH&P's cumulative over- or under-recovery of fuel bills from November 1, 1980 through October 31, 1982.
