AN EXAMINATION BY THE PUBLIC SERVICE COMMISSION OF THE APPLICATION OF THE FUEL ADJUSTMENT CLAUSE OF OWEN COUNTY RURAL ELECTRIC COOPERATIVE CORPORATION FROM NOVEMBER 1, 1980 TO OCTOBER 31, 1982

ORDER

IT IS ORDERED that Owen County Rural Electric Cooperative Corporation ("Owen County") shall file an original and six copies of the following information with the Commission by December 17, 1982. When a number of sheets are required for an item, each sheet should be appropriately indexed; for example, Item 1(a), Sheet 2 of 6. Owen County shall furnish with each response the name of the witness who will be available at the public hearing for responding to questions concerning each area of information requested. Careful attention should be given to copied material to insure that it is legible. If neither the requested information nor a motion for an extension of time is filed by the stated date, the fuel adjustment clause may be suspended.

(1) Provide the following line loss information:

- (a) A schedule of the calculation of the 12-month average line loss by month for the period of November 1980 through October 1982.
- (b) A discussion of the steps that have been taken to reduce line loss during this period.



- (2) Provide a schedule showing the calculation of Owen County's cumulative over- or under-recovery of fuel bills from November 1, 1980 through October 31, 1982.
- (3) Provide a copy of Owen County's Monthly Revenue Reports (Monthly Billing Summaries) showing the total revenue collected, including adjustments, under the fuel adjustment clause reported in Owen County's Monthly filings required by the Commission from November 1, 1980, through October 31, 1982.
- (4) Owen County shall submit any comments it has regarding Appendix A which the Commission is considering requiring in lieu of the monthly filing currently required by the Commission.
