ORDER

On July 7, 1983, the Public Service Commission ("Commission") entered an Order in Case No. 8602 wherein it approved the fuel adjustment charges collected by Green River Electric Corporation ("Green River") through the fuel adjustment clause for the period November 1, 1980, through October 31, 1982, and authorized Green River to adjust its rates in order to transfer to its base rates fuel costs transferred by its wholesale supplier pursuant to Case No. 8587.

Green River notified the Commission by letter dated July 13, 1983, that Appendix A to the Order is incorrect in that rates for Howmet Aluminum were not included. Further, the energy charge adder used in calculating rates for Large Industrial Customers Served Under Special Contracts should have been that of the wholesale electric supplier, rather than that of Green River, since there is no line loss associated with Green River's service to these customers.

The Commission has confirmed Green River's findings and amended the Appendix to the Order issued in this Case.

IT IS THEREFORE ORDERED that Revised Appendix A be and it hereby is approved for service rendered on and after July 1, 1983.

IT IS FURTHER ORDERED that all other provisions of the Commission's Order entered July 7, 1983, not amended herein shall remain in full force and effect.
