O R D E R

On July 21, 1983, BEEP-ALERT of Kentucky, Inc., ("BEEP-ALERT") filed with the Commission its application seeking a certificate of convenience and necessity for authorization to provide radio common carrier tone and voice paging service in the Fayette County area of Kentucky.

A hearing was held in the Commission's offices at Frankfort, Kentucky, on September 8, 1983. No intervenors appeared at the hearing.

BEEP-ALERT proposes to construct or otherwise obtain all necessary facilities to provide these services as more specifically set out in the application and record.

Findings and ORDER

The Commission, having considered the application and evidence of record and being advised, is of the opinion and finds that:

(1) Public convenience and necessity require that such service as is proposed in the application and record be performed, and that a certificate of convenience and necessity be granted; and

(2) The rates and charges proposed in the application and exhibits are fair, just, and reasonable, and should be effective with the institution of the proposed service.

IT IS THEREFORE ORDERED that BEEP-ALERT be and it hereby is granted a certificate of public convenience and necessity to proceed with the provision of service as set forth in the application and record.

IT IS FURTHER ORDERED that BEEP-ALERT shall file with the Commission, at least 30 days prior to the initiation of such service, its tariff setting forth its rules, regulations and rates in the manner prescribed by the regulations of the Commission.

IT IS FURTHER ORDERED that the rates and charges in Appendix A be and they hereby are approved with the institution of the service approved herein.

APPENDIX TO AN ORDER OF THE KENTUCKY PUBLIC SERVICE
COMMISSION IN CASE NO. 8877 DATED OCTOBER 14, 1983.

Schedule of Charges

- 1.) Direct Dial Paging - Tone and Voice Message.
 - a.) The length and number of calls applicable for such service shall be limited as follows:
 - (1) Length of transmission - not in excess of ten (10) seconds.
 - (2) Number of calls per month.
 - a.) Unlimited - \$15.00 Per Month Per Unit
- 2.) Direct Dial Paging - Tone
 - a.) Number of calls - Unlimited.
 - (1) Unlimited - \$9.00 Per Month Per Unit
 - (2) Dual Address - \$1.00 Per Month Per Unit
 - (3) Display Paging - \$14.00 Per Month Per Unit
- 3.) Reconnect Charges.
 - a.) If a subscriber is disconnected for non-payment, a re-connection charge will made.
 - (1) Reconnect Charge - \$25.00
