## ORDER

On November 23, 1982, the Commission issued its Order in Case No. 8546 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates when the wholesale cost of gas is increased or decreased or a refund is received.

On February 10, 1984, Elzie Neeley Gas Company, Inc., ("Elzie Neeley") notified the Commission that its wholesale cost of gas would be increased by its supplier, Columbia Gas of Rentucky, Inc., ("Columbia") effective March 1, 1984, and submitted with its notice certain information in compliance with its purchased gas adjustment clause on file with this Commission.

After reviewing the record in this case and being advised, the Commission is of the opinion and finds that:

(1) Elzie Neeley's notice of February 10, 1984, set out certain revisions in rates which Elzie Neeley proposed to place into effect, said rates being designed to pass on the wholesale increase in price from its supplier in the amount of \$296 or 2.5 cents per Mcf. (2) Elzie Neeley's wholesale cost of gas will be increased by Columbia effective March 1, 1984.

(3) Elzie Neeley's adjustment in rates under the purchased gas adjustment provisions approved by the Commission in its Order in Case No. 8546 dated November 23, 1982, is fair, just and reasonable and in the public interest and should be effective with gas supplied on and after March 1, 1984, subject to refund. This adjustment is subject to refund because Columbia's rates are subject to refund.

IT IS THEREFORE ORDERED that the rates in the Appendix to this Order be and they hereby are authorized effective with gas supplied on and after March 1, 1984, subject to refund.

IT IS FURTHER ORDERED that within 30 days of the date of this Order Elzie Neeley shall file with this Commission its revised tariffs setting out the rates authorized herein.
