O R D E R

On May 9, 1983, the Commission issued its Order in Case No. 8730 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates when the wholesale cost of gas is increased or decreased or a refund is received.

On February 8, 1984, Martin Gas, Inc., ("Martin") notified the Commission that its wholesale cost of gas would be increased by its supplier, Columbia Gas of Kentucky, Inc., ("Columbia") effective March 1, 1984, and submitted with its notice certain information in compliance with its purchased gas adjustment clause on file with this Commission. On February 10, 1984, Martin filed amended schedules in this Case.

After reviewing the record in this case and being advised, the Commission is of the opinion and finds that:

(1) Martin's notice of February 10, 1984, set out certain revisions in rates which Martin proposed to place into effect,

said rates being designed to pass on the wholesale increase in price from its supplier in the amount of \$1,381 or 2.5 cents per Mcf.

(2) Martin's wholesale cost of gas will be increased by Columbia effective March 1, 1984.

(3) Martin's adjustment in rates under the purchased gas adjustment provisions approved by the Commission in its Order in Case No. 8730 dated May 9, 1983, is fair, just and reasonable and in the public interest and should be effective with gas supplied on and after March 1, 1984, subject to refund. This adjustment is subject to refund because Columbia's rates are subject to refund.


IT IS THEREFORE ORDERED that the rates in the Appendix to this Order be and they hereby are authorized effective with gas supplied on and after March 1, 1984, subject to refund.

IT IS FURTHER ORDERED that within 30 days of the date of this Order Martin shall file with this Commission its revised tariffs setting out the rates authorized herein.

APPENDIX TO AN ORDER OF THE KENTUCKY PUBLIC SERVICE
COMMISSION IN CASE NO. 8730-G DATED 2/17/84

The following rates and charges are prescribed for the customers served by Martin Gas, Inc. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the effective date of this Order.

RATES: Monthly

First 1 Mcf	\$6.9418 Per Mcf
Over 1 Mcf	6.8418 Per Mcf

Minimum Bill

The minimum bill shall be \$7.00

The base rate for the future application of the purchased gas adjustment clause of Martin Gas, Inc., shall be:
