ORDER

On June 27, 1984, Cincinnati Bell Telephone filed a proposed tariff which would extensively amend its present tariffs dealing with regulated equipment currently for sale and would eliminate from its existing tariffs all sale items no longer available from the regulated embedded inventory or in Accounts 231 or 234.

The proposed tariff would also establish provisions for the sale of complete regulated embedded Customer Premises Equipment (CPE) communications systems or portions of such systems to its customers.

The Commission is of the opinion and finds that further investigation and possible hearing will be necessary to determine the reasonableness of the proposed tariff.

IT IS THEREFORE ORDERED that the proposed tariff be and hereby is suspended for 5 months from the proposed effective date of July 18, 1984. The pages of the tariff hereby suspended are:
