ORDER

On December 1, 1983, the Commission issued its Order in Case No. 8839 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates when the wholesale cost of gas is increased or decreased or a refund is received.

On August 7, 1985, Western Kentucky Gas Company ("Western") notified the Commission that its wholesale cost of gas had been decreased by its supplier, Tennessee Gas Pipeline Company ("Tennessee Gas"), effective August 15, 1985, and submitted with its notice certain information in compliance with its purchased gas adjustment clause on file with this Commission.

After reviewing the record in this case and being advised, the Commission is of the opinion and finds that:

(1) Western's notice of August 7, 1985, set out certain revisions in rates which Western proposed to place into effect, said rates being designed to pass on the wholesale decrease in price from its supplier in the amount of \$1,593,767 or 24.34 cents per Mcf.

(2) On July 26, 1985, Tennessee Gas filed revised rates with the Federal Energy Regulatory Commission to be effective August 15, 1985.

(3) Inasmuch as the filing of revised tariffs by Tennessee Gas was too late for Western to make timely filings, Western has proposed to implement reduced rates effective September 1, 1985, and refund any excess revenues collected during the period from August 15, 1985, to August 31, 1985, to its customers.

(4) Western's adjustment in rates under the purchased gas adjustment provisions approved by the Commission in its Order in Case No. 8839, dated December 1, 1983, is fair, just and reasonable and in the public interest and should be effective with gas supplied on and after September 1, 1985.


IT IS THEREFORE ORDERED that the rates in the Appendix to this Order be and they hereby are authorized effective with gas supplied on and after September 1, 1985.

IT IS FURTHER ORDERED that within 30 days of the date of this Order Western shall report to this Commission any excess rates collected during the period from August 15, 1985, to the date the proposed rates are implemented, along with a plan to refund any excess collections to its customers.

IT IS FURTHER ORDERED that within 30 days of the date of this Order Western shall file with this Commission its revised tariffs setting out the rates authorized herein.

APPENDIX TO AN ORDER OF THE KENTUCKY PUBLIC SERVICE  
COMMISSION IN CASE NO. 8839-R DATED 8/26/85

The following rates and charges are prescribed for the customers in the area served by Western Kentucky Gas Company. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the date of this Order.

RATES:

Purchased Gas Adjustment

To each bill rendered under the above-named rate schedules, there shall be added an amount equal to: (\$0.2434) per Mcf of gas used during the billing period.
