O R D E R

On December 1, 1983, the Commission issued its Order in Case No. 8839 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates when the wholesale cost of gas is increased or decreased or a refund is received.

On December 10, 1985, Western Kentucky Gas Company ("Western") notified the Commission that its wholesale cost of gas had been increased by its suppliers, Tennessee Gas Pipeline Company ("Tennessee Gas"), Texas Gas Transmission Corporation ("Texas Gas") and local producers, effective January 1, 1986, and submitted with its notice certain information in compliance with its purchased gas adjustment clause on file with this Commission.

After reviewing the record in this case and being advised, the Commission is of the opinion and finds that:

(1) Western's notice of December 10, 1985, set out certain revisions in rates which Western proposed to place into effect, said rates being designed to pass on the wholesale increase in price from its suppliers in the amount of \$409,160 or 1.12 cents per Mcf.

(2) Tennessee Gas, filed revised rates with the Federal Energy Regulatory Commission ("FERC") to be effective January 1, 1986.

(3) Texas Gas filed revised rates with the FERC to be effective January 1, 1986.

(4) Western's adjustments in rates under the purchased gas adjustment provisions approved by the Commission in its Order in Case No. 8839, dated December 1, 1983, are fair, just and reasonable and in the public interest and should be effective with gas supplied on and after January 1, 1986. This adjustment is subject to refund because its suppliers' increase is subject to refund.

IT IS THEREFORE ORDERED that:

(1) The rates in the Appendix to this Order be and they hereby are authorized effective with gas supplied on and after January 1, 1986, subject to refund.

(2) Within 30 days of the date of this Order Western shall file with this Commission its revised tariffs setting out the rates authorized herein.

APPENDIX TO AN ORDER OF THE KENTUCKY PUBLIC SERVICE  
COMMISSION IN CASE NO. 8839-V DATED 12/17/85

The following rates and charges are prescribed for the customers in the area served by Western Kentucky Gas Company. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the effective date of this Order.
