THE NOTICE OF PURCHASED GAS) ADJUSTMENT FILING OF LOUISVILLE) CASE NO. 8924-F GAS AND ELECTRIC COMPANY)

ORDER

On June 25, 1984, the Commission issued its Order in Case No. 8924 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates when the wholesale cost of gas is increased or decreased or a refund is received. On January 7, 1985, the Commission issued its Order in Case No. 9133 providing for further adjustment of these rates on a quarterly basis in accordance with the provisions of the Gas Supply Cost Adjustment ("GSCA") clause set forth therein.

On April 10, 1985, Louisville Gas and Electric Company ("LG&E") filed its initial guarterly gas cost adjustment which is to become effective May 1, 1985, and is to remain in effect through July 31, 1985.

After reviewing the record in this case and being advised, the Commission is of the opinion and finds that:

1. LG&E's notice of April 10, 1985, set out certain revisions in rates which LG&E proposed to place into effect, said rates being designed to recover the expected wholesale gas costs from its supplier calculated in accordance with its GSCA procedures. 2. LG&E proposed an expected gas supply cost adjustment of 1.833 cents per 100 cubic feet above that included in its base rates. This amount has been adjusted for gas purchased for storage and non-gas department purposes.

3. LG&E's notice set out a total refund factor of 0.205 cents per 100 cubic feet. This factor includes a current quarter supplier refund of \$147,145 plus interest which is due LG&E's customers.

4. The adjustment in rates set out in the Appendix to this Order, determined under the GSCA provisions approved by the Commission in Case No. 8924 dated June 25, 1984, and Case No. 9133 dated January 7, 1985, is fair, just and reasonable and in the public interest and should be effective with gas supplied on and after May 1, 1985.

IT IS THEREFORE ORDERED that the rates in the Appendix to this Order be and they hereby are authorized effective with gas supplied on and after May 1, 1985.

IT IS FURTHER ORDERED that within 30 days from the date of this Order LG&E shall file with this Commission its revised tariffs setting out the rates authorized herein.
