ORDER

On October 9, 1984, the Commission entered an Order in this proceeding, pursuant to KRS 74.361, requiring that the McKinney Water Association be merged into the McKinney Water District by January 1, 1985. By Order entered March 29, 1985, the Commission extended the merger date to October 1, 1985.

On September 4, 1985, the McKinney Water District, by counsel, filed with the Commission a revised timetable¹ setting forth the necessary steps with dates to accomplish the merger. The revised timetable contemplated that by October 21, 1985, both the McKinney Water District and McKinney Water Association would have formally approved a contract for sale and purchase of the latter's assets.

The Commission having received no report on the status of the merger since the filing of the revised timetable, is of the opinion and hereby finds that a status report should be filed within 10 days.

IT IS THEREFORE ORDERED that within 10 days of the date of this Order the McKinney Water District and McKinney Water Association shall file individually or collectively a report on the status of their merger as contemplated in their revised timetable.
