AMENDED ORDER OF PROCEDURE

On January 2, 1985, Big Rivers Electric Corporation ("Big Rivers"), by counsel, filed a Motion for an extension to and including January 15, 1985, to answer data requests.

On January 3, 1985, the Attorney General of the Commonwealth of Kentucky, by and through his Consumer Protection Division, filed a response to Big Rivers' motion, stating that he has no objection to the eleven day extension so long as all subsequent dates included in the Commission's procedural schedule are extended by an identical eleven day period.

IT IS THEREFORE ORDERED That the Motion of Big Rivers be and it hereby is granted to the extent that Big Rivers has to and including January 14, 1985, to answer data requests.

IT IS FURTHER ORDERED That the new procedural schedule set forth in Appendix A to this Order supersedes the schedule set forth in the Commission's December 5, 1984, Order.
