O R D E R

IT IS ORDERED that Union Light, Heat and Power Company ("ULH&P") shall file an original and six copies of the following information with the Commission by March 15, 1985, with a copy to all parties of record. Each copy of the data requested shall be placed in a bound volume with each item tabbed. When a number of sheets is required for an item, each sheet shall be appropriately indexed; for example, Item 1(a), Sheet 2 of 6. ULH&P shall furnish with each response the name of the witness who will be available at the public hearing to respond to questions concerning each area of information requested. Careful attention shall be given to copied material to insure that it is legible. If neither the requested information nor a motion for an extension of time is filed by the stated date, ULH&P's fuel adjustment clause may be suspended.

1. Provide ULH&P's monthly purchases and sales for each of the last 6 months under review (May 1984 through October 1984) as shown in Format 1.

2. Provide CG&E's monthly EFC rate schedules ER-2 through ER-12 filed pursuant to the Public Utilities Commission of Ohio Order No. 80-928-ORD dated February 2, 1982, under PUCO tariff No. 17 for each of the last 6 months under review (May 1984 through October 1984).

3. Provide a schedule showing the calculation of the increase or decrease in ULH&P's base fuel cost per KWH using its annual average fuel cost per KWH for the year ended October 31, 1984.

4. Provide a schedule of the present and proposed rates which ULH&P would change pursuant to 807 KAR 5:056 using the amount calculated in Item 3 above.
