AMENDED ORDER

On February 12, 1985, the Commission issued an Order in the above-styled case granting approval of the transfer of the assets of Multi-Page, Inc., ("Multi-Page") to Commonwealth Telecommunications, Inc. ("Comtel"). On March 4, 1985, Multi-Page and Comtel filed a joint application for rehearing. The purpose of the application was to clarify certain language in the body of the Order. No opposition was raised with regard to the Summary Section of the Commission's Order of Februay 12, 1985.

Specifically, the applicants requested that the following sentence he deleted: "However the Commission also notes from the Operating Agreement filed by Multi-Page and Comtel that Multi-Page will retain control over all facilities, equipment, revenues and profits from the business and that Comtel will serve chiefly as a sales and distribution agent for Multi-Page". The basis for their

request was that the Operating Agreement would become invalid upon final approval of the Federal Communications Commission ("FCC") and the Commission. Since the FCC's approval was granted subsequent to the the Commission's approval, deleting the questioned sentence is inappropriate. However, the Commission is of the opinion that its February 12, 1985, Order should be modified to include the following language to complete the questioned sentence: "until such time as final approval is granted by all regulatory agencies."

IT IS THEREFORE ORDERED that Multi-Page and Comtel's joint application to amend the Commission's Order of February 12, 1985, to delete the sentence concerning Multi-Page's retention of control over facilities, equipment, revenues and profits from the business be and it hereby is denied.

IT IS FURTHER OPDERED that the following amended language be and it hereby is approved: "However the Commission also notes from the Operating Agreement filed by Multi-Page and Comtel that Multi-Page will retain control over all facilities, equipment, revenues, and profits from the business and that Comtel will serve chiefly as a sales and distribution agent for Multi-Page until such time as final approval is granted by all regulatory agencies."

IT IS FURTHER ORDERED that all other portions of the Commission's February 12, 1985, Order not specifically mentioned herein shall remain in full force and effect.
