O R D E R

IT IS ORDERED that Sanitation District No. 2 of McCracken County, Kentucky ("McCracken") shall file an original and 8 copies of the following information with the Commission by May 3, 1985, with a copy to all parties of record. If neither the requested information nor a motion for an extension of time is filed by the stated date, the case may be dismissed.

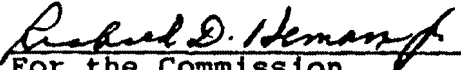
