O R D E R

On February 19, 1985, Union Light, Heat and Power Company ("ULH&P") filed an application requesting an Order from the Commission approving revisions to its gas tariff, P.S.C. Ky. No. 2, Sheet No. 16, Charge for Reconnection of Service, and its electric tariff, P.S.C. Ky. No. 3, Sheet No. 42, Charge for Reconnection of Service and Sheet No. 45, Bad Debt Charge.

ULH&P requested that the electric tariff, Charge for Reconnection of Service, be increased from the present charge of \$6.00 to a charge of \$15.00 and included within its application cost justification for the proposed increase. Additionally, ULH&P stated that the requested change to \$15.00 would equalize the charge for electric customers with the charge for gas customers approved by the Commission in Case No. 9029.

ULH&P requested a change in the electric tariff to increase the bad check charge from the present \$5.00 charge to the proposed \$8.00 charge, which is identical to the amount approved by the Commission in Case No. 9029 for the gas tariff.

ULH&P filed exhibits reflecting the amount of additional revenues to be generated from the proposed tariff revisions. Based upon the 12-month period ended November 30, 1984, the additional revenue would provide for an approximate increase of 2.4 percent in all electric miscellaneous and non-recurring revenues.

FINDINGS AND ORDER

The Commission, after examining the evidence of record and being advised, is of the opinion and finds that:

1. The proposed charge of \$15.00 by ULH&P for the reconnection of service in the electric tariff is fair, just and reasonable.

2. The proposed charge of \$8.00 by ULH&P for a bad check in the electric tariff is fair, just and reasonable.

3. The tariff revisions to P.S.C. Ky. No. 2, Sheet No. 16, Charge for Reconnection of Service, P.S.C. Ky. No. 3, Sheet No. 42, Charge for Reconnection of Service and P.S.C. Ky. No. 3, Sheet No. 45, Bad Debt Charge, should be accepted as proposed by ULH&P.


IT IS THEREFORE ORDERED that the tariff revisions proposed by ULH&P to P.S.C. Ky. No. 2, Sheet No. 16, P.S.C. Ky. No. 3, Sheet No. 42, and P.S.C. Ky. No. 3, Sheet No. 45 be and they hereby are effective on and after the date of this Order.

IT IS FURTHER ORDERED that ULH&P shall file with this Commission within 20 days of the date of this Order the following revised tariff sheets as proposed in its application:

P.S.C. Ky. No. 2, Sheet No. 16, Charge for Reconnection of Service
P.S.C. Ky. No. 3, Sheet No. 42, Charge for Reconnection of Service
P.S.C. Ky. No. 3, Sheet No. 45, Bad Check Charge
