O R D E R

IT IS ORDERED that Kentucky-American Water Company ("Kentucky-American") shall file an original and 12 copies of the following information with the Commission by June 14, 1985, with a copy to all parties of record. Each copy of the data requested should be placed in a bound volume with each item tabbed. When a number of sheets is required for an item, each sheet should be appropriately indexed, for example, Item 1(a), Sheet 2 of 6. Include with each response the name of the witness who will be responsible for responding to questions relating to the information provided. Careful attention should be given to copied material to insure that it is legible. Where information requested herein has been provided along with the original application, in the format requested herein, reference may be made to the specific location of said information in responding to this information request. When applicable, the information requested herein should be provided for total company operations and jurisdictional operations, separately. If neither the

requested information nor a motion for an extension of time is filed by the stated date, the case may be dismissed.

1. Revise the Partial Factor Productivity for Kentucky-American presented in Exhibit 1 of Mr. Eden's testimony in view of the difference in the method of calculating total employee hours expensed in 1972 and 1984 as mentioned in response to LFUCG Question 107.

2. Provide the Partial Factor Productivity data for Kentucky-American for the years 1980, 1981, 1982, and 1983.

3. Provide an explanation for the difference in the ratio of pounds of chemicals to water pumped for Kentucky-American when compared to the same ratio for the other companies referred to on page 3 of Mr. Edgemon's testimony.

4. Provide a status report on updates to the Kentucky-American Transition Water Demand Model. (Mr. Young's testimony.)

5. Identify the Camp Dresser McKee ("CDM") recommendations that have been accepted. (Mr. Young's testimony.)

6. Describe the changes in data collection and forecasting methods that have been implemented as a result of the CDM recommendations. (Mr. Young's testimony.)

7. Were any CDM recommendations rejected? If so, why? (Mr. Young's testimony.)

8. Was the 1985 update of the 1980 Comprehensive Plan conducted? If so, please provide a copy. (Mr. Young's testimony.)

9. With regard to the response to LFUCG, Item 3, provide:

(a) A detailed explanation of the 21.09 percent increase in Account #932, Outside Services Employed.

(b) A detailed explanation of the substantial increase in Account #631, Maintenance of Structures and Improvements, Pumping Expenses and Account #651, Maintenance of Structures and Improvements, Water Treatment Expenses.

10. With regard to its response to LFUCG, Item 14. It appears that in 1984 Kentucky-American expensed \$3,544 property taxes that were for the 1983 calendar year. Please explain.
