O R D E R

On March 27, 1985, Beep Alert of Kentucky, Inc., ("Beep Alert") filed an application for a certificate of public convenience and necessity to construct facilities and expand its service area to include Franklin County and portions of Anderson, Scott, Shelby and Woodford counties. On May 1, 1985, letters were sent to the various certified paging companies operating in this area and there was no request for intervention.

Beep Alert was granted a certificate of convenience and necessity to provide tone and voice paging services in the Fayette County, Kentucky, area by the Commission on October 14, 1983, in Case No. 8877. On November 16, 1984, the Federal Communications Commission authorized Beep Alert to construct facilities at latitude 38-12-44 North, longitude 048-53-07 West on Clifty Dr., Belle Point, Frankfort, Kentucky. The base transmitter will operate on a frequency of 43.5800 MHz. The antenna will radiate

power omni-directionally with an effective radiated power of 311 watts. Maintenance and repair of the facilities operated by Beep Alert will be performed by Mr. James R. Woodruff who is the holder of a "General Radiotelephone Operator License" and provides the maintenance and repair services for Beep Alert's facilities in Fayette County, Kentucky.

The Commission, having considered the evidence of record and being advised, is of the opinion and finds that:

(1) The services proposed by Beep Alert will enhance the services currently available to the public in Franklin County and portions of Anderson, Scott, Shelby and Woodford counties.

(2) No new rates or tariffs were proposed for the services to be provided in the Franklin County area; therefore, the rates and tariffs utilized by Beep Alert in its Fayette County area are appropriate for the services to be provided in the Franklin County area.

(3) Beep Alert is financially and technically capable of operating and providing radio paging services.


(4) Beep Alert should be granted a certificate of convenience and necessity to construct facilities and provide paging service to the public.


IT IS THEREFORE ORDERED that Beep Alert be and it hereby is granted a certificate of public convenience and necessity to construct facilities and provide services to the public in Franklin County and portions of Anderson County, Scott County, Shelby County and Woodford County.


IT IS FURTHER ORDERED that Beep Alert shall file revised tariff sheets to include the additional area to be served 30 days prior to the institution of service in the Franklin, Anderson, Scott, Shelby and Woodford county areas.
