COMPLAINT

The Complaint of KENNETH HURT, minor, by ADLIA MILLER, next friend, respectfully shows:

- a. That Kenneth Hurt and Adlia Miller reside at Bridge Hollow, Jackson, Kentucky 41339, and are unemployed.
- b. That Kentucky Power Company, Defendant, has a registered agent named Robert E. Matthews, Box 1428, 1701 Central Avenue, Ashland, Kentucky 41101.
- c. That on or about August 13th, 1985, Defendant transferred to the account of Kenneth Hurt overdue amounts of an account of Leonard Little and/or a Martha Miller. The amounts transferred were \$652.19 and \$378.25.
- d. Neither Kenneth Hurt nor Adlia Miller gave authority for the transfer nor did they ever agree to be responsible for the account transferred.
- e. On or about October 7th, 1985, Defendant discontinued electrical service to the residence of Complainant for failure to pay the transferred overdue account. Said disconnection was in violation of 807.KAR 5:006(11).

WHEREFORE, KENNETH HURT by next friend, ADLIA
MILLER; Complainant, asks that the Commission order Defendant
to cancel the wrongful transfer, to restore electrical service
to Complainant and to adopt a regulation requiring notice and
a hearing prior to such a transfer.
