ORDER

On January 13, 1986, the Commission issued its Order in Case No. 9375 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates when the wholesale cost of gas is increased or decreased or a refund is received.

On March 14, 1986, Elam Utility Company ("Elam") notified the Commission that its wholesale cost of gas would be decreased by its supplier, Columbia Gas Transmission Corporation ("Transmission"), and submitted with its notice certain information in compliance with its purchased gas adjustment clause on file with this Commission.

After reviewing the record in this case and being advised, the Commission is of the opinion and finds that:

(1) Elam's notice of March 14, 1986, set out certain revisions which Elam proposed to place into effect, said rates being designed to pass on the wholesale decrease in price from its supplier in the amount of \$1,546 or 3.74 cents per Mcf.

- (2) Transmission has filed for decreased rates effective April 1, 1986, with the Federal Energy Regulatory Commission ("FERC").
- (3) Elam's adjustment in rates under the purchased gas adjustment provisions approved by the Commission in its Order in Case No. 9375 dated January 13, 1986, is fair, just and reasonable and in the public interest and should be effective with gas supplied on and after April 1, 1986.

IT IS THEREFORE ORDERED that:

- (1) The rates in the Appendix to this Order be and they hereby are authorized effective with gas supplied on and after April 1, 1986.
- (2) Within 30 days of the date of this Order Elam shall file with this Commission its revised tariffs setting out the rates authorized herein.
