# ORDER

On December 8, 1976, the Commission issued its Order in Case No. 6602, approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates when the wholesale cost of gas is increased or decreased or a refund is received.

On June 16, 1986, Equitable Gas Company ("Equitable") notified the Commission that its wholesale cost of gas had been decreased by its supplier, Kentucky West Virginia Gas Company ("Kentucky West"), effective June 7, 1986, and submitted with its notice certain information in compliance with its purchased gas adjustment clause on file with this Commission.

After reviewing the record in this case and being advised, the Commission is of the opinion and finds that:

(1) Equitable's notice of June 16, 1986, set out certain revisions in rates which Equitable proposed to place into effect, said rates being designed to pass on the wholesale decrease in price from its supplier in the amount of \$77,287 or 14.87 cents per Mcf.

- (2) Kentucky West filed an application for decreased rates to become effective June 7, 1986, with the Federal Energy Regulatory Commission.
- (3) Equitable should report to the Commission the amount of any excess revenues collected from June 7, 1986, to the date the proposed rates are implemented, along with a plan to refund excess revenues to its customers.
- Equitable included in its application of June 16, 1986, the amount of overcollections resulting from its decrease in Case Equitable requested approval net the No. 6602-DD. to overcollection of \$25,155 against an undercollection Equitable experienced during the months of March, April and May. undercollection of \$35,344 occurred when Equitable failed to file for increased rates effective March 1, 1986, due to a change in Equitable waives claim to personnel responsible for PGA filings. Equitable should be the remaining \$10,189 of undercollections. allowed to net the two amounts and should not be required to refund the overcollections in view of the sizeable amount of undercollections.
- (5) Equitable's adjustment in rates under the purchased gas adjustment provisions approved by the Commission in its Order in Case No. 6602 dated December 8, 1976, is fair, just and reasonable and in the public interest and should be effective with gas supplied on and after June 7, 1986.

IT IS THEREFORE ORDERED that:

- (1) The rates in the Appendix to this Order be and they hereby are authorized effective with gas supplied on and after June 7, 1986.
- (2) Within 30 days from the date of this Order Equitable shall file with this Commission the amount of any excess revenues collected and a refund plan.
- (3) The excess revenues collected from Case No. 6602-DD shall be netted against undercollections and, therefore, shall not be refunded.
- (4) Within 30 days of the date of this Order Equitable shall file with this Commission its revised tariffs setting out the rates authorized herein.
