### ORDER

On October 1, 1986, South Hopkins Water District ("South Hopkins") filed its revised tariff sheet with the Public Service Commission ("Commission") setting forth its rates as adjusted pursuant to KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the evidence of record and being advised, is of the opinion and finds that:

- 1. South Hopkins' supplier, Dawson Springs Municipal Water and Sewer System ("Dawson Springs"), increased its wholesale rate for purchased water effective for the year ending June 30, 1986. Dawson Springs calculates its water production costs annually and bills South Hopkins retroactively for the additional costs of the water sold to it during the prior year.
- 2. South Hopkins purchased 179,525,300 gallons of water and sold 150,889,780 gallons during the 12-month period ending June 30, 1986.
- 3. South Hopkins' calculations are correct and show an increase in purchased water costs of \$9,502 resulting in a purchased water adjustment of \$.06 per 1,000 gallons.
- 4. South Hopkins adjusted its rates to its customers by \$.06 per 1,000 gallons, effective September 8, 1986.

5. The tariff sheet filed by South Hopkins is incorrect in that it does not provide the information necessary to be shown on tariffs under 807 KAR 5:011, Section 15. South Hopkins should file revised tariff sheets in accordance with the above stated regulation.

IT IS THEREFORE ORDERED that:

- 1. The rates as adjusted by South Hopkins and shown in Appendix A be and they hereby are approved effective for services rendered on and after September 8, 1986.
- 2. Within 30 days of the date of this Order, South Hopkins shall file revised tariff sheets in accordance with 807 KAR 5:011, Section 15, setting out the rates approved herein.
- 3. Within 30 days of the date of this Order, South Hopkins shall file a copy of the notice to its customers of the increased rates, along with proof of such notice.
