### ORDER

On November 6, 1986, Campbell County Water District ("Campbell County") filed its revised tariff sheet with the Public Service Commission ("Commission") for the purpose of adjusting its rates pursuant to KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the evidence of record and being advised, is of the opinion and finds that:

- 1. Campbell County purchases water from the City of Newport and Kenton County Water District.
- 2. The City of Newport increased its rate for purchased water from \$.3508 to \$.3970 per 1,000 gallons effective September 1, 1986.
- 3. Campbell County purchased a total of 1,745,477,300 gallons of water during the 12-month period ending September 30, 1986.
- 4. Campbell County used an incorrect base rate in making its calculations. On November 20, 1986, Campbell County was sent a letter showing the correct base rate of \$.3508 to be used in this case. On December 1, 1986, the Commission received a letter from Campbell County wherein it agreed with the Commission's revised base rate.

- 5. Campbell County failed to properly include in its filing a revised rate for its wholesale customers. An adjustment for the wholesale customers has been included in the Commission's calculations and set out in Appendix B.
- 6. Based on Campbell County's increase from its supplier the increase in purchased water cost is \$70,838, resulting in a purchased water adjustment of \$.05 per 1,000 gallons.
- 7. Campbell County will adjust the rates to its customers by \$.05 per 1,000 gallons, effective December 6, 1986.

IT IS THEREFORE ORDERED that:

- The rates shown in Appendix A be and they hereby are approved effective for services rendered on and after December 6, 1986.
- 2. The base rate for purchased water be and it hereby is 40.08 cents per 1,000 gallons.
- 3. Campbell County shall file its revised tariff sheets setting out the rates approved herein within 30 days of the date of this Order.
