O R D E R

On December 8, 1982, the Commission issued its Order in Case No. 8568 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates when the wholesale cost of gas is increased or decreased or a refund is received.

On January 21, 1987, Pendleton County Water District, Gas Division, ("Pendleton") notified the Commission that it will receive a decrease in rates from its supplier, Columbia Gas Transmission Corporation ("Transmission"), effective January 1, 1987, and submitted with its notice certain information in compliance with its purchased gas adjustment clause on file with this Commission.

After reviewing the record in this case and being advised, the Commission is of the opinion and finds that:

(1) Pendleton's notice of January 21, 1987, set out certain revisions in rates which Pendleton proposes to place into effect, said rates being designed to pass on a wholesale decrease in rates from its supplier in the amount of \$2,595 or 1.48 cents per Mcf.

(2) Transmission filed an application for decreased rates with the Federal Energy Regulatory Commission to become effective January 1, 1987.

(3) Pendleton should file with this Commission the amount of excess revenues collected from January 1, 1987, to the date the proposed rates are implemented, along with a refund plan.

(4) Pendleton's adjustment in rates under the purchased gas adjustment provisions approved by the Commission in its Order of December 8, 1982, is fair, just and reasonable and in the public interest and should be effective with gas supplied on and after January 1, 1987.

IT IS THEREFORE ORDERED that:


(1) The rates in the Appendix to this Order be and they hereby are authorized effective with gas supplied on and after January 1, 1987.


(2) Within 30 days of the date of this Order Pendleton shall file with this Commission its revised tariffs setting out the rates authorized herein.

(3) Within 30 days of the date of this Order Pendleton shall file with this Commission the amount of excess revenues collected and its refund plan.
