### ORDER

On July 10, 1986, the Commission issued its Order in Case No. 9515 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates when the wholesale cost of gas is increased or decreased or a refund is received.

On August 13, 1987, Phelps Gas Company, Inc., ("Phelps") notified the Commission that its wholesale cost of gas had been decreased by its supplier Columbia Gas of Kentucky, Inc., ("Columbia") effective September 1, 1987, and submitted with its notice certain information in compliance with its purchased gas adjustment clause on file with this Commission.

After reviewing the record in this case and being advised, the Commission is of the opinion and finds that:

(1) Phelps' notice of August 13, 1987, set out certain revisions in rates which Phelps proposed to place into effect, said rates being designed to pass on the wholesale decrease in price from its supplier in the amount of \$7,889 or 42.76 cents per Mcf. (2) Phelps' wholesale cost of gas was decreased by Columbia effective September 1, 1987.

(3) Phelps' proposed adjustment in rates under the purchased gas adjustment provisions approved by the Commission in its Order in Case No. 9515 dated July 10, 1986, is fair, just, and reasonable and in the public interest and should be effective with gas supplied on and after September 1, 1987.

IT IS THEREFORE ORDERED that:

(1) The rates in the Appendix to this Order be and they hereby are authorized effective with gas supplied on and after September 1, 1987.

(2) Within 30 days of the date of this Order Phelps shall file with this Commission its revised tariffs setting out the rates authorized herein.
