O R D E R

On October 31, 1986, the Commission issued its Order in Case No. 9556 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates on a quarterly basis in accordance with the provisions of the Gas Cost Adjustment ("GCA") Clause set forth therein.

On October 1, 1987, Western Kentucky Gas Company ("Western") filed its quarterly GCA which is to become effective November 1, 1987, and is to remain in effect until January 31, 1988.

After reviewing the record in this case and being advised, the Commission is of the opinion and finds that:

(1) Western's notice of October 1, 1987, set out certain revisions in rates which Western proposed to place into effect, said rates being designed to pass on the overall wholesale decrease in gas costs from its suppliers in the amount of 3.05 cents per Mcf.

(2) Western's notice set out a total refund adjustment of .89 cents per Mcf.

(3) Western's notice set out an actual adjustment of 4.33 cents per Mcf to return previous overcollections to its customers.

(4) Because this is Western's third GCA filing, it has no balance adjustment.

(5) Western proposed a gas cost adjustment ("GCA"), or a decrease from its Base Cost of Gas Component, of 34.57 cents per Mcf. This decrease represents the combined effect of the supplier decrease, the refund adjustment and the actual adjustment.

(6) Western's adjustments in rates under the provisions approved by the Commission in its Order in Case No. 9556, dated October 31, 1986, are fair, just, and reasonable and in the public interest and should be effective with gas supplied on and after November 1, 1987.

IT IS THEREFORE ORDERED that:

(1) The rates in the Appendix to this Order be and they hereby are authorized effective with gas supplied on and after November 1, 1987.

(2) The GCA shall be 34.57 cents per Mcf effective with final meter readings on and after November 1, 1987.


(3) Within 30 days of the date of this Order Western shall file with this Commission its revised tariffs setting out the rates authorized herein.


(4) Western shall continue to charge all its transportation customers using gross margin transportation rates.

(5) Western shall calculate its expected gas cost by including all Tennessee charges in commodity charges as authorized herein.
