O R D E R

On November 19, 1986, 4-Way Enterprises, Inc., Coolbrook Sewage Treatment Plant, ("4-Way") filed an application seeking an increase in rates in order to generate additional revenues of \$14,994 annually, an increase of approximately 39 percent over adjusted test year revenues of \$38,119. On December 11, 1986, the Commission granted deviation from 807 KAR 5:076, Section 1, by allowing a test period of September 1, 1985, through August 31, 1986.

On December 9, 1986, the Commission staff performed a limited review of 4-Way's operations for the purpose of evaluating the requested increase in rates. On February 11, 1987, the staff issued its report containing findings and recommendations related to the requested increase. 4-Way did not file any comments in response to the staff report and did not request a public hearing.

The staff report, based on the Commission's usual rate-making practices, recommended that 4-Way be granted an increase of \$10,167. The Commission finds the recommendations contained in the report to be reasonable and, therefore, will grant the

increase of \$10,167 resulting in annual operating revenues of \$48,229.

SUMMARY

The Commission, based on the evidence of record and being advised, is of the opinion and finds that:


1. The rate proposed by 4-Way should be denied upon application of KRS 278.030.
2. The rate in Appendix A is fair, just and reasonable for 4-Way and should produce gross annual revenues of \$48,229.

IT IS THEREFORE ORDERED that:

1. The rate proposed by 4-Way be and it hereby is denied.
2. The rate in Appendix A is approved for service rendered by 4-Way on and after the date of this Order.
3. Within 30 days of the date of this Order, 4-Way shall file its revised tariff sheets setting out the rate approved herein.
