## ORDER

On August 10, 1987, the Commission issued its Order in Case No. 9918 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates when the wholesale cost of gas is increased or decreased or a refund is received.

On July 14, 1988, Mt. Olivet Natural Gas Company, Inc. ("Mt. Olivet") notified the Commission that it will receive a decrease in rates from its supplier, Columbia Gas Transmission Corporation ("Transmission"), effective August 1, 1988, and submitted with its notice certain information in compliance with its purchased gas adjustment clause ("PGA") on file with this Commission.

After reviewing the record in this case and being advised, the Commission is of the opinion and finds that:

(1) Mt. Olivet's notice of July 14, 1988 set out certain revisions in rates which Mt. Olivet proposed to place into effect, said rates being designed to pass on the wholesale decrease in gas cost from its supplier in the amount of \$6,992 or 17.8 cents per Mcf. (2) Transmission filed revised rates with the FERC to be effective August 1, 1988. These rates are subject to refund.

(3) Mt. Olivet's adjustments in rates under the PGA provisions approved by the Commission in its Order in Case No. 9918 dated August 10, 1987 are fair, just, and reasonable and in the public interest and should be effective with gas supplied on and after August 1, 1988. Mt. Olivet's rates should be subject to refund because Transmission's rates are subject to refund.

IT IS THEREFORE ORDERED that:

(1) The rates in the Appendix to this Order be and they hereby are authorized effective with gas supplied on and after August 1, 1988, subject to refund.

(2) Within 30 days from the date of this Order, Mt. Olivet shall file with this Commission its revised tariff sheets setting out the rates authorized herein.
