ORDER

On August 1, 1988, Jessamine County Water District No. 1 ("Jessamine") filed its revised tariff sheet with the Public Service Commission ("Commission") for the purpose of adjusting its rates pursuant to KRS 278.015 and 807 KAR 5:068, Purchased Water Adjustment.

The Commission, having reviewed the evidence of record and being advised, is of the opinion and finds that:

- 1. Jessamine's supplier, City of Nicholasville, increased its rate for wholesale water from \$.81 to \$1.43 per 1,000 gallons effective June 15, 1988. The monthly service charge was increased from \$2.50 to \$3.75.
- 2. Jessamine increased the rates to its customers, effective June 15, 1988.
- 3. During the 12 months ending July 31, 1988, Jessamine purchased 87,076,910 gallons of water and sold 72,707,980 gallons.
- 4. Jessamine's calculations are correct and show an increase in purchased water costs of \$54,003, resulting in a purchased water adjustment of \$.74 per 1,000 gallons.

- 5. The purchased water adjustment of \$.74 per 1,000 gallons and the rates in Appendix A are fair, just, and reasonable and should be approved.
- 6. Jessamine's tariff sheet is correct and should be approved as filed.

IT IS THEREFORE ORDERED that:

- 1. The purchased water adjustment of \$.74 per 1,000 gallons and the rates in Appendix A are hereby approved for services rendered on and after June 15, 1988.
- 2. Jessamine's proposed tariff sheet is hereby approved as filed.
