O R D E R

On August 26, 1988, Marion County Water District ("Marion") filed its revised tariff sheet with the Public Service Commission ("Commission") for the purpose of adjusting its rates pursuant to KRS 278.015 and 807 KAR 5:068, Purchased Water Adjustment.

The Commission, having reviewed the evidence of record and being advised, is of the opinion and finds that:

1. On January 1, 1988, Marion's supplier, Lebanon Water Works Company, Inc., increased its rates for wholesale water by approximately \$.08 per 100 cubic feet.

2. Marion proposes to increase the rates to its customers effective on and after the date of the Commission's Order.

3. During the 12 months ending July 31, 1988, Marion purchased 33,038,910 cubic feet of water (247,131,047 gallons)¹ and sold 208,217,050 gallons.

4. The increased cost of purchased water is \$26,999, resulting in a purchased water adjustment of \$.13 per 1,000 gallons of water.

¹ 33,038,910 cubic feet X 7.48 = 247,131,046.8 gallons

5. The purchased water adjustment of \$.13 per 1,000 gallons and the rates in Appendix A are fair, just, and reasonable and should be approved.

6. Marion's proposed tariff is correct and should be approved.

IT IS THEREFORE ORDERED that:


1. The purchased water adjustment in the amount of \$.13 per 1,000 gallons and the rates in Appendix A are hereby approved for services rendered on and after the date of this Order.

2. Marion's proposed tariff sheet is hereby approved as filed.

3. Within 30 days of the date of this Order Marion should file a copy of the notice to its customers and verification that such notice has been given.

The following rates and charges are prescribed for the customers in the area served by Marion County Water District. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the effective date of this Order.

First 1,000 gallons	\$7.73 Minimum
Next 9,000 gallons	1.80 per 1,000 gallons
Next 90,000 gallons	1.38 per 1,000 gallons
Over 100,000 gallons	1.13 per 1,000 gallons

5/8 inch or 3/4 inch meter	\$ 7.73
1 inch meter	12.13
2 inch meter	16.88
