that Nolin Rural Electric Cooperative IT IS ORDERED Corporation ("Nolin RECC") shall file an original and 12 copies of the following information with the Commission with a copy to all parties of record no later than 21 days after the issuance of this If the information cannot be provided by this date, Nolin Order. RECC should submit a motion for an extension of time stating the reason a delay is necessary and include a date by which it will be Such motion will be considered by the Commission. furnished. Nolin RECC shall furnish with each response the name of the witness who will be available at the public hearing for responding to questions concerning each item of information requested.

1. Describe the circumstances of each case in which the underbilling occurred. List the date in which the underbilling occurred. Explain how the underbilling was discovered.

2. Provide a copy of the Blands' billing records for the period beginning one year prior to the underbilling and ending one year following the end of the underbilling.

3. How long had the Blands received electric service from Nolin RECC before the underbilling began? Was this service provided to the same location during this time?

4. Provide a copy of the Farrises' billing records for the period beginning one year prior to the underbilling and ending one year following the end of the underbilling.

5. How long had the Farrises received electric service from Nolin RECC before the underbilling began? Was this service provided to the same location during this time?

6. Provide a copy of all correspondence between the Blands and Nolin RECC concerning the underbilling. Also provide a copy of all internal memoranda on meetings or telephone conversations between Nolin RECC and the Blands where the underbilling was discussed.

7. Provide a copy of all correspondence between the Farrises and Nolin RECC concerning the underbilling. Also provide a copy of all internal memoranda on meetings or telephone conversations between Nolin RECC and the Farrises where the underbilling was discussed.

8. Have Nolin RECC and the Blands executed a written agreement on the amount of the underbilling which the Blands will pay? If yes, provide a copy of this agreement.

9. Have Nolin RECC and the Farrises executed a written agreement on the amount of the underbilling which the Farrises will pay? If yes, provide a copy of this agreement.

10. In both cases, has the exact amount of electric energy used during the period of underbilling been determined? If yes, please state these amounts.

11. Explain how Nolin RECC determined that \$1500 is the appropriate portion of the underbilling for the Blands to pay.

12... Explain how Nolin RECC determined that \$494 is the appropriate portion of the underbilling for the Farrises to pay.

13. KRS 278.160(2) states: "No utility shall charge, demand, collect or receive from any person a greater or less compensation for any service rendered than that prescribed in its rate schedules. . ." How does Nolin RECC reconcile its proposed settlement with KRS 278.160(2)?
