ORDER

On July 19, 1979, the Commission issued its Order in Case No. 7341 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates when the wholesale cost of gas is increased or decreased or a refund is received.

On July 7, 1989, Belfry Gas, Inc. ("Belfry") notified the Commission that its wholesale cost of gas will be increased by its supplier, Columbia Gas Transmission Corporation ("Transmission"), effective August 1, 1989, and submitted with its notice certain information in compliance with its purchased gas adjustment ("PGA") clause on file with this Commission.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission is of the opinion and finds that:

(1) Belfry's notice of July 7, 1989 set out a wholesale increase in price from its supplier in the amount of \$17,200 or 21 cent per Mcf.

(2) Transmission applied with the Federal Energy Regulatory Commission for increased rates to become effective August 1, 1989. Belfry requested a waiver of the 30-day filing requirement. Pursuant to KRS 278.180, upon Belfry's showing of good cause, Belfry's effective date for the increase should be August 1, 1989. Transmission's rates are subject to refund; therefore, Belfry's rates should be subject to refund.

(3) Belfry's adjustment in rates under the purchased gas adjustment provisions approved by the Commission in its Order in Case No. 7341 dated July 19, 1979 is fair, just, and reasonable and in the public interest and should be effective with gas supplied on and after August 1, 1989, subject to refund.

IT IS THEREFORE ORDERED that:

(1) The rates in the Appendix, attached hereto and incorporated herein, are fair, just, and reasonable and are approved effective with gas supplied on and after August 1, 1989, subject to refund.

(2) Within 30 days of the date of this Order, Belfry shall file with this Commission its revised tariffs setting out the rates authorized herein.
