O R D E R

On October 31, 1986, the Commission issued its Order in Case No. 9556 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates on a quarterly basis in accordance with the provisions of the Gas Cost Adjustment ("GCA") Clause set forth therein.

On July 3, 1989, Western Kentucky Gas Company ("Western") filed its quarterly GCA which is to become effective August 1, 1989 and is to remain in effect until October 31, 1989.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission is of the opinion and finds that:

(1) Western's notice of July 3, 1989 set out certain revisions in rates which Western proposed to place into effect, said rates being designed to pass on the overall wholesale increase in gas costs from its suppliers in the amount of 13.18 cents per Mcf.

(2) Western's notice set out a total refund adjustment of .25 cents per Mcf, which returns the remaining refunds from previous quarters.

(3) Western's notice set out an actual adjustment of 6.30 cents per Mcf to return previous overcollections to its customers.

(4) Western's notice set out a balance adjustment in the amount of 1.15 cents per Mcf to reconcile previous actual adjustments.

(5) Western proposed a GCA of (17.75) cents per Mcf. This adjustment represents the combined effect of the supplier increase, the refund, actual and balancing adjustments. The effect on retail rates is a 9.78 cent per Mcf increase.

(6) In its filing of July 3, 1989, Western requested a waiver of the 30-day notice period required by statute. Western's effective date should be August 1, 1989.

(7) Western's adjustments in rates under the provisions approved by the Commission in its Order in Case No. 9556 dated October 31, 1986, are fair, just, and reasonable and in the public interest and should be effective with final meter readings on and after August 1, 1989.

(8) Western's filing of July 3, 1989 included supplementary information concerning its actual adjustment for which it requested confidentiality. Confidentiality should be granted pending Commission review of all other gas supply confidentiality requests.

IT IS THEREFORE ORDERED that:

(1) The rates in the Appendix to this Order, attached hereto and incorporated herein, are fair, just, and reasonable and are approved effective with final meter readings on and after August 1, 1989.


(2) The GCA shall be (17.75) cents per Mcf effective with final meter readings on and after August 1, 1989.


(3) Within 30 days of the date of this Order, Western shall file with this Commission its revised tariffs setting out the rates authorized herein.


(4) Western's supplemental information shall be accorded confidential treatment pending Commission review of all gas supply confidentiality requests.
