ORDER

This matter arising upon A & B Sanitation Company, Inc.'s ("A & B Sanitation") objections to the Commission's amended staff report and motion for rehearing, and it appearing from an informal conference that good cause exists for rehearing, and this Commission being otherwise advised,

IT IS ORDERED:

- 1. A rehearing be and is hereby scheduled for Monday, August 7, 1989, at 10:00 a.m., Eastern Daylight Time, in Hearing Room 2, at 677 Commanche Trail of the Commission's offices in Frankfort, Kentucky, for the purpose of considering testimony and other evidence.
- 2. A & B Sanitation shall on or before July 28, 1989 furnish and file with the Commission the following:
- a. A statement setting forth in detail each objection to the amended staff report, including its reasons for believing that the report is in error.

- b. A detailed list of all inventory items which A & B Sanitation intends to purchase and provide three written estimates of the cost of each item.
- c. Three written estimates for the cost of each of the following expenses:
 - (1) Insurance
 - (2) Testing
 - (3) Rent (include location and number of square feet)
- d. For each rental location listed in 2(c), identify each utility service that will be purchased and furnish written estimates of the monthly cost.
- e. Provide a description of all proposed accounting and legal services to be obtained and furnish three written estimates of the cost for each service.
- f. With respect to each of the expenses listed in paragraph b, c, d, and e above, state what proportion will be borne by A & B Sanitation and what proportion will be born by E. P. Sanitation and further explain how the proportionate method was determined.
- 3. A & B Sanitation shall publish in a newspaper published in the area having the largest bona fide circulation, the following notice, such notice to be published no earlier than 21 days prior to the hearing and no later than 7 days prior to the hearing:

NOTICE TO THE CUSTOMERS OF A & B SANITATION COMPANY, INC.

You are hereby notified that a public rehearing will be held before the Public Service Commission in Hearing Room 2 of the Commission's offices at 677 Commanche Trail, Frankfort, Kentucky, on Monday, August 7, 1989 at 10:00 a.m., Eastern Daylight Time, for

the purpose of considering testimony and other evidence concerning the application of A & B Sanitation Company, Inc. for a rate increase.

4. Copies of all documents and other information filed with the Commission shall be served upon all parties of record.
