ORDER TO CEASE AND DESIST AND TO SHOW CAUSE

Right Beaver Gas Company ("Right Beaver") has pending before this Commission an application for approval of a rate increase. A final Order addressing the requested rate increase has not been issued in this case.

The Commission has recently received documentation showing that Right Beaver has implemented the unapproved rate increase without Commission approval by billing its customers at the higher rate beginning with the January 1989 billing cycle. The Commission has also received at least one informal complaint through the Consumer Services Hotline. Copies of the billing at the increased rate are attached as Appendix A to this Order.

Based upon the bills attached and incorporated as Appendix A and the complaint received, the Commission finds that a prima facie showing has been established that Right Beaver has increased its rates without Commission approval and in violation of the provisions of KRS Chapter 278.

IT IS THEREFORE ORDERED that:

- 1. Right Beaver shall immediately cease and desist from charging any rates which have not been approved by the Commission.
- 2. Right Beaver shall appear and show cause, if any it can, why it should not be penalized under KRS 278.990 for violating provisions of KRS Chapter 278 including, but not limited to, KRS 278.160 at a hearing scheduled for February 13, 1989, at 1:30 p.m., Eastern Standard Time, in Hearing Room No. 2 at the Commission's offices in Frankfort, Kentucky,
- 3. At the above-scheduled hearing Right Beaver shall also be prepared to demonstrate a plan for refunding or crediting customer accounts for any unauthorized amounts collected. Such plan shall include the names of those customers from which the charges were collected and the amount for each customer that shall be refunded or credited.
