O R D E R

IT IS ORDERED that LDD, Inc. ("LDD") shall file an original and ten copies of the following information with the Commission, with a copy to all parties of record. The information requested herein is due no later than March 30, 1989. If the information cannot be provided by this date, LDD should submit a motion for an extension of time stating the reason a delay is necessary and include a date by which it can be furnished. Such a motion will be considered by the Commission.

1. Provide a complete description of the manner in which LDD will be providing services within Kentucky. In addition:

a. Identify the facilities-based carriers whose services LDD intends to resell.

b. If LDD intends to resell tariffed services of facilities-based services, identify these tariffed services, and specify whether these services will be obtained from intrastate or interstate tariffs.

c. If LDD intends to sell services that are not available under an approved tariff, provide copies of the contracts which govern the terms of the agreements between LDD and its facilities-based carriers.

d. Provide a sketch showing all of LDD's points of presence and switching locations. On this sketch, show how the facilities obtained from facilities-based carriers will be used to connect these locations. Include local access facilities, and identify the local access that will be used.

2. If switching locations or points of presence are located outside of Kentucky, please explain how LDD will ensure that intrastate access charges will be paid.

3. Identify the services that will be utilized to offer intraLATA services.

4. If LDD intends to resell services or facilities of carriers that are not authorized for intraLATA resale, please explain the methods that will be used to ensure that these services or facilities will not carry intraLATA traffic.

5. Provide a toll-free number and point-of-contact for customer complaints.

6. Provide an estimate of sales revenues for LDD's first 2 years of Kentucky operations. Also explain how LDD arrived at these estimates. If the estimates are based upon a market study, please provide a copy of this study.

7. State the Kentucky counties LDD proposes to service initially and those which it anticipates adding at later dates.


8. Provide a listing of financial institutions with which LDD has a line of credit. Also, state LDD's credit line with each of these institutions.

9. Provide a copy of the note associated with the \$988,809 note payable listed as a liability on LDD's October 31, 1988 Balance Sheet.

10. State whether LDD is aware of the provisions of the Kentucky Public Service Commission Administrative Case No. 273 that will apply to LDD's Kentucky operations.
