ORDER

Pursuant to KRS 74.395(2), IT IS HEREBY ORDERED that:

- 1. A public hearing shall be held on December 14, 1989, at 1:30 p.m., Eastern Standard Time, at the Commission's offices in Frankfort, Kentucky, to examine the application of the Reidland Water and Sewer District for approval to add a temporary surcharge to its water rates to finance proposed construction and improvements to its waterworks system. Individuals interested in attending this hearing shall notify the Public Service Commission in writing of their intent to attend no later than December 7, 1989.
