AMENDED ORDER

On March 2, 1990, an Order was entered regarding amendments to Commission administrative regulations on gas safety and service (807 KAR 5:022), gas gathering systems (807 KAR 5:026), reporting of gas leaks (807 KAR 5:027), and electric (807 KAR 5:041). The Commission submitted these amendments to the Legislative Research Commission ("LRC") on February 15, 1990 with the intent to implement the amendments to the above regulations in conformity with the provisions of KRS Chapter 13A.

These regulations were previously filed with the LRC on December 15, 1989 and were mailed in January 1990 to those jurisdictional utilities impacted by the amendments. The differences in the text of the regulations previously filed and those filed with the LRC on February 15, 1990 were detailed in Appendix A of the March 2, 1990 Order. The differences in the text included those changes which were recommended in the written comments filed prior to the public hearing on January 23, 1990. The regulations as amended appear in the March 1, 1990 issue of the Kentucky Administrative Register ("Register").

Due to administrative oversight, Appendix A of the March 2, 1990 Order does not include two amendments which were submitted to the LRC on February 15, 1990 regarding 807 KAR 5:041. These two amendments are detailed in Appendix A, attached hereto and incorporated herein. Each was recommended in written comments filed prior to the January 23, 1990 hearing and are included as amendments in the March 1, 1990 issue of the Register.

IT IS THEREFORE ORDERED, to be entered <u>nunc pro tunc</u>, that the amendments in Appendix A are hereby made a part of the record in this proceeding.

APPENDIX TO AN ORDER OF THE KENTUCKY PUBLIC SERVICE COMMISSION IN ADMINISTRATIVE CASE NO. 332 DATED 3/12/90

SUMMARY OF CHANGES

807 KAR 5:041

Section 2(5) now reads "The adoption and applicability of the National Electrical Code as a standard of utility construction is limited to electric utility auxiliary buildings which are not an integral part of a generating plant, substation, or control center. Integral part is defined as essential to the operation or necessary to make complete."

Section 13(4), in the second sentence of the section, the term "rotating" has been changed to "watthour."
