ORDER

On September 17, 1986, the Commission issued its Order in Case No. 9535 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates when the wholesale cost of gas is increased or decreased or a refund is received.

On May 24, 1990, Mike Little Gas Company, Inc. ("Mike Little") notified the Commission that its wholesale cost of gas was decreased by its supplier, Kentucky West Virginia Gas Company ("Kentucky West"), effective May 1, 1990. Mike Little submitted with its notice certain information in compliance with its purchased gas adjustment clause on file with this Commission.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Mike Little's notice of May 24, 1990 set out certain revisions in rates which Mike Little proposed to place into effect, said rates being designed to pass on the wholesale decrease in price from its supplier in the amount of \$74,079 or \$1.3243 per Mcf.

- 2. Kentucky West filed an application with the Federal Energy Regulatory Commission for decreased rates with an effective date of May 1, 1990. Kentucky West's rates are subject to refund; hence, Mike Little's rates should be subject to refund.
- 3. Mike Little should file with this Commission the amount of any overcollections received from May 1, 1990 to the date the approved rates are implemented, along with a refund plan.
- 4. The adjustment in Mike Little's rates under the purchased gas adjustment provisions approved by the Commission in its Order in Case No. 9535 dated September 17, 1986 is fair, just, and reasonable, in the public interest, and should be effective with gas supplied on and after May 1, 1990, subject to refund.

IT IS THEREFORE ORDERED that:

- 1. The rates in the Appendix, attached hereto and incorporated herein, are hereby authorized effective with gas supplied on and after May 1, 1990, subject to refund.
- 2. Within 30 days of the date of this Order, Mike Little shall file with this Commission its revised tariffs setting out the rates authorized herein.
- 3. Within 30 days of the date of this Order, Mike Little shall file the amount of any excess revenues collected, along with a refund plan.

The following rates and charges are prescribed for the customers in the area served by Mike Little Gas Company, Inc. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the effective date of this Order.
