ORDER

On September 17, 1986, the Commission issued its Order in Case No. 9535 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates when the wholesale cost of gas is increased or decreased or a refund is received.

On August 22, 1990, Mike Little Gas Company, Inc. ("Mike Little") notified the Commission that its wholesale cost of gas was increased by its supplier, Kentucky West Virginia Gas Company ("Kentucky West"), effective August 1, 1990. Mike Little submitted with its notice certain information in compliance with its purchased gas adjustment clause on file with this Commission.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Mike Little's notice of August 22, 1990 set out certain revisions in rates which Mike Little proposed to place into effect, said rates being designed to pass on the wholesale

increase in price from its supplier in the amount of \$7,784 or 15.03 cents per Mcf.

- 2. Kentucky West filed an application for revised rates to become effective August 1, 1990 with the Federal Energy Regulatory Commission. Mike Little requested a waiver of the 30-day filing requirement. Pursuant to KRS 278.180, upon Mike Little's showing of good cause, Mike Little's request should be granted. The effective date for Mike Little's rates should be on and after the date of this Order. Kentucky West's rates are subject to refund; hence, Mike Little's rates should be subject to refund.
- 3. The adjustment in Mike Little's rates under the purchased gas adjustment provisions approved by the Commission in its Order in Case No. 9535 dated September 17, 1986 is fair, just, and reasonable, in the public interest, and should be effective with gas supplied on and after the date of this Order, subject to refund.

IT IS THEREFORE ORDERED that:

- 1. The rates in the Appendix, attached hereto and incorporated herein, are hereby authorized effective with gas supplied on and after the date of this Order, subject to refund.
- 2. Within 30 days of the date of this Order, Mike Little shall file with this Commission its revised tariffs setting out the rates authorized herein.
