ORDER

Equitable Gas Company ("Equitable"), a Division of Equitable Resources, Inc., filed its application for a rate increase with a proposed effective date of December 29, 1989. However, due to filing deficiencies in its application the proposed effective date for the increase should be 30 days from the date those deficiencies were cured or March 11, 1990. The Commission, being otherwise sufficiently advised, finds that pursuant to KRS 278.190, further proceedings are necessary in order to determine the reasonableness of the proposed rates and that such proceedings cannot be completed prior to the proposed effective date.

IT IS THEREFORE ORDERED that:

- 1. The proposed rates are hereby suspended for 5 months from the proposed effective date, through August 11, 1990.
- 2. The procedural schedule set forth in the Appendix to this Order, attached hereto and incorporated herein, shall be adhered to in the above-styled proceeding.
- 3. Nothing in this Order shall prevent the Commission from entering a final decision in this case prior to the termination of the suspension period.
