O R D E R

Before the Commission is the application of Big Sandy Rural Electric Cooperative Corporation ("Big Sandy") for approval of a revision to its electric power tariff. The application was filed as a result of a proposed decrease in power costs from Big Sandy's wholesale power supplier, East Kentucky Power Cooperative, Inc. ("EKPC").¹ The rates proposed by Big Sandy are intended to flow-through to its customers the scheduled power cost reduction from EKPC. Big Sandy's revised tariff was to have become effective December 1, 1989 but was suspended for a period of 5 months.

The Commission, having considered the evidence of record and being otherwise sufficiently advised, finds that:

1. EKPC, Big Sandy's wholesale power supplier, has been authorized to reduce its rates for wholesale electric power.

2. Big Sandy should be authorized to reduce its rates in order to effect a flow-through of the wholesale power cost reduction from EKPC.

3. The rates and charges in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and will accomplish a flow-through of the power cost reduction from EKPC.


IT IS THEREFORE ORDERED that:

1. The rates and charges in Appendix A are approved for service rendered by Big Sandy on and after January 1, 1990.

2. Within 30 days from the date of this Order, Big Sandy shall file with the Commission its revised tariff sheets setting out the rates approved herein.
