ORDER OF PROCEDURE

Aqua Corporation ("Aqua") having filed an application with the Commission wherein it proposes to adjust its retail rates for service rendered on and after March 5, 1990, and the Commission finding that further proceedings are necessary to determine the reasonableness of Aqua's proposed rates and that such proceedings cannot be completed prior to the proposed effective date,

IT IS HEREBY ORDERED that:

1. The proposed rates hereby are suspended for 5 months from the proposed effective date through August 5, 1990.
2. Aqua shall provide public notice of the proposed rates in accordance with the provisions set out in 807 KAR 5:011, Section 8(2) and (3).
3. The procedural schedule listed in Appendix A, attached hereto and incorporated herein, shall be followed.
4. All requests for information and responses thereto shall be appropriately indexed. All responses shall include the name of the witness who will be responsible for responding to the

questions related to the information provided, with copies to all parties of record and 12 copies to the Commission.


5. Aqua shall give notice of the hearing in accordance with the provisions set out in 807 KAR 5:011, Section 8(5).

6. Motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of compelling reasons.

7. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
