ORDER

On April 4, 1990, Aqua Corporation ("Aqua") moved for an extension of time to April 30, 1990 to comply with the Commission's March 14, 1990 Order. As grounds for its motion, Aqua states that the requested information is voluminous and requires manual compilation of several years of data. It further states that other pressing obligations prevent its staff from completing this compilation before April 30, 1990.

After reviewing Aqua's motion and being otherwise sufficiently advised, the Commission finds that good cause exists to grant the motion. We further find that the information sought by the March 14, 1990 Order is necessary for a full and complete evaluation of Aqua's application and that Aqua's delay in filing the requested information will impede the intervenors' ability to conduct discovery and prepare their witnesses' testimony. Accordingly, the existing procedural schedule should be amended to ensure that all parties have adequate time to conduct discovery and to review the information provided.

IT IS THEREFORE ORDERED that:

- 1. Aqua's motion for an extension of time in which to comply with the Commission's Order of March 14, 1990 is granted.
- 2. The procedural schedule set forth in the Commission's Order of March 2, 1990 is hereby amended as shown in Appendix A of this Order. All parties shall follow this amended procedural schedule.
