O R D E R

On December 28, 1989, East Laurel Water District ("East Laurel") filed its revised tariff with the Public Service Commission ("Commission") for the purpose of adjusting its rates pursuant to the purchased water adjustment procedure. KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the evidence of record and being sufficiently advised, finds:

1. East Laurel's supplier, Wood Creek Water District, increased its rate for purchased water from \$1.05 to \$1.15 per 1,000 gallons effective November 22, 1989.

2. East Laurel increased the rates to its customers effective January 1, 1990.

3. During the 12 months ending November 30, 1989, East Laurel purchased 137,307,900 gallons and sold 116,711,700 gallons.

4. East Laurel's calculations are correct and show an increase in purchased water costs of \$13,731 resulting in a purchased water adjustment of 12 cents per 1,000 gallons.

5. The purchased water adjustment in the amount of 12 cents per 1,000 gallons and the rates in Appendix A are fair, just, and reasonable and should be approved.

6. The tariff sheet filed by East Laurel is correct and should be approved.

IT IS THEREFORE ORDERED that:


1. The purchased water adjustment in the amount of 12 cents per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are approved for services rendered on and after January 1, 1990.


2. The tariff sheet filed by East Laurel is hereby approved.


3. Within 30 days of the date of this Order, East Laurel shall file a copy of the notice to its customers and verification that such notice has been given.

APPENDIX A

APPENDIX TO AN ORDER OF THE KENTUCKY PUBLIC SERVICE  
COMMISSION IN CASE NO. 89-381 DATED 1/29/90

The following rates and charges are prescribed for the customers in the area served by East Laurel Water District. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the effective date of this Order.

Minimum Water Rates Based on Size Connections

<u>Size of Meter Connection</u>	<u>Number of Gallons or less of Water to be provided for the Minimum Rate</u>	<u>Minimum Monthly Water Rate</u>
5/8 x 3/4 inch	2,000 gallons	\$ 9.02
1 inch	6,000 gallons	21.52
2 inch	20,000 gallons	50.74
3 inch	30,000 gallons	70.84
4 inch	50,000 gallons	111.04
6 inch	100,000 gallons	211.54

Meter Rates for Water Usage in Addition to Minimum Charge

Subject to the minimum monthly water rates specified above, the following metered charges shall be made for 1,000 gallons of water consumption per month to customers of all size connections.

<u>Number of Gallons of Water Per Month</u>	<u>Monthly Charge Per 1,000 Gallons Per Month</u>
First 2,000 gallons	\$9.02 Minimum Bill
Next 2,000 gallons	3.39 per 1,000 gallons
Next 2,000 gallons	2.86 per 1,000 gallons
Next 4,000 gallons	2.28 per 1,000 gallons
All over 10,000 gallons	2.01 per 1,000 gallons
